Please refer to our e-circular No. CDO/P&HRD-IR/78/2020-21 dated 19.01.2021, wherein it was advised that the Bank has obtained a Group Term Policy No. 72100274804 from SBI Life Insurance Company Limited, covering outstandings in all Home Loan accounts of employees/ retired employees opened under individual Housing Loan Scheme (IHLS) of the Bank. The policy term was 01.11.2020 to 31.10.2021.

- 2. The Group Term Policy No. 72100274804 obtained from SBI Live Insurance Company Limited has since been renewed after a tendering process for the period 01.11.2021 to 31.10.2022 covering outstandings in all Home Loan accounts of employees/retired employees opened under Individual Housing Loan Scheme (IHLS) of the Bank.
- 3. The premium for the policy is paid by the Bank centrally at Corporate Office.
- 4. Copies of the Master Policy, Claim Form & List of Housing Loan accounts as on 30.09.2021 covered under the Policy are available on State Bank Times/Human Resources/Industrial Relations.

It is therefore, advised that if any IHLS account is outstanding in the name of deceased pensioners, this may be brought to the notice of the Bank immediately so that the Bank can claim the amount under Insurance Policy and claim the amount for closing the same.

GOT A CALL FOR UPDATING YOUR KYC DEBIT & CREDIT CARDS

Modus Operandi

- * You will get a call from unidentified number, asking you to update KYC.
- * The KYC can be for your bank account, SIM card, e-wallet or any other account.
- * Either you will be told that the account has been blocked or it will get blocked if process is not expedited.
- * The caller will then ask you to install Anydesk app.
- * Once this is done, they can operate your device remotely.
- * Then they will ask you to make a token payment, which helps them access your account.
- * Alternatively, they will share a link to click on; once it's done, they will use the data to access your account.

Dos and Dont's

- * Never share your account details such as account number, login ID, Password, PIN, UPI-PIN, OTP, debit card/credit card details with anyone, not even with bank officials, however genuine they might sound.
- * Do not respond to offers for getting KYC updated or expedited. Always access the official website of your bank/NBFC/e-wallet provider or contact the branch.
- * Do not download any unknown app on your phone/ device. The app may access your confidential data secretly.
- * Transactions involving receipt of money do not require scanning barcodes/QR codes or entering MPIN. Thus, exercise caution if asked to do so.
- * Always access the official website of bank/NBFC/ewallet provider for contact details. Contact numbers on internet search engines may be fraudulent.
- * If you receive an OTP for debiting your account for a transaction not initiated by you, inform your bank/ e-wallet provide immediately.
- * Do not share password of your email linked to your bank/e-wallet account.
- * Secure your cards and set daily limit for transactions.
 This can limit loss due to fraud.
