Editorial...

Respected Pensioners/Retiree Members,

As I have already mentioned in my previous information regarding last two years happenings i.e. w.e.f. 19.03.2020 onwards, through my editorial column, I once again apprise all of you all the developments of SBI Pensioners' Association, Chandigarh Circle.

In the month of April 2020, when Covid-19 was spreading throughout the World, we had requested our members for the donations towards P.M. Care Fund/SBI Chairman's Foundation Account. The members contributed liberally and the Association was able to collect above Eight lacs rupees and a sum of Rs.4,26,000/- each (Rs. Four lacs Twenty thousand only) was remitted to the above funds totalling Rs.8,52,000/- (Rupees Eight lacs Fifty Two thousands only) for the very noble cause of humanity for the help of the Covid affected patients. Our this gesture was applauded and appreciated by the then Chief General Manager Sh. Rana Ashutosh Kumar Singh Ji through D.O. Letter addressed to the General Secretary (now Dy. Managing Director). Once again, I am thankful and appreciate our members contribution, on behalf of SBI Pensioners' Association, Chandigarh Circle.

On our taking up the matter with the Bank's management, we were able to convince them for continuance of the medicines, clinical tests etc. from 01.04.2020 onwards regularly from the Bank's dispensaries. During that very crucial period, our members availed this facility continuously for their general medicine requirements.

We have been regularly sending/sharing Whatsapp messages to all of members regarding any type of informations received by us from the Bank as well as from the Federation of SBI Pensioners, from time to time enabling our members to know the developments at their end. Since our regular meetings were stopped due to Covid-19, we could not share with the new members physically. But the proforma of our Membership Form were regularly sent to the new retirees during this period on Whatsapp and you would be happy to note that good percentage of the fresh retirees became members of the Association numbering about Eight hundred (Approx.) during this period i.e. w.e.f. 01.04.2020 onwards and at present our Association has the strength of little over 6700 (Six thousand Seven hundred).

Now with the easing of the Covid-19 scenario, the Bank has allowed us to hold our meeting in a month w.e.f. Nov. 2021 onwards minus January 2022 when Covid-19 cases were going upwards. About 70/80 members are attending these monthly meetings at the North Block, Ground Floor of Local Head Office, Chandigarh. In between we had our structured meeting on 4th March, 2022 at LHO building which was chaired by our respected Dy. General Manager, CDO Sh. Teekam Singh Gehlot and attended by AGM (PPFG), AGM (OAD) and AGM (Personnel & HRA) and the Chief Managers of HRD Deptt. & Chief Manager of PPFG Deptt. From our side S/Sh. K.P. Joshi, Offg. President; T.R. Gupta, General Secretary; K.K. Trikha, Dy. General Secretary; S.K. Sharma, Treasurer, S.C. Aggarwal, Organising Secretary and Tek Chand from the local headquarters and S/Sh. S.P. Aggarwal, Vice President, Haryana Module; U.S. Negi, Vice President, H.P. Module; Vinod Kalia from Ludhiana Module; S. Rawal from Haryana Module and Vijay Sachdeva from Jalandhar Module. The meeting was very fruitful and the Agenda items were discussed with the management representatives with a very positive response from them. We are grateful to respected Dy. General Manager, CDO and his team over the matter.

On 9th December, 2020, Structured Meeting with the Corporate Centre was held at Hyderabad in which our two Governing Body members S/Sh. T.R. Gupta and S.K. Sharma attended the same. From the Bank's side, respected Om Parkash Mishra Ji, Dy. Managing Director and C.D.O. at Corporate Office headed their team and Federation of SBI Pensioners' Associations were led by our President Sh. G.K. Gandhi and General Secretary Sh. Ramesh Babu. It was a very cordial meeting and our above mentioned leaders and other members took up the Agenda items very forcefully with humble request to the Management of the Bank. The very next day i.e. on 10th and 11th December, 2021, the A.G.M. of the Federation of SBIPA was held at Hyderabad in which six office-bearers from our circle participated namely S/Sh. K.P. Joshi, T.R. Gupta, K.K. Trikha, S.K. Sharma, S.P. Aggarwal and U.S. Negi. In the meeting, latest developments were

discussed and a fresh agenda items for taking up the necessary actions for the rightful needful. Again, it was very well conducted meeting by our Hyderabad Circle Team of SBIPA.

On 24.03.2022, the Circle Executive Committee meeting was held and 24 participants from the circle excluding our J&K module because of nonparticipation from their module. In between two E.C. meetings of the Circle were held in March, 2021 and September, 2021. In the last meeting i.e. 24.03.2022, it was decided to enhance the one time membership fee of Rs.1800/- to Rs.2200/- for clerical and officer members and from 1200/- to Rs.1500/- for the subordinate staff & family pensioner members. It was also decided to hold our Annual General Elections by the end of May, 2022, preferably in some big space outside LHO because of social distance needs and other S.O.P.'s of Covid-19. So, if Covid-19 position do not go negative, we are trying our best efforts to hold the same by May, 2022 and schedule of the elections, the names of the Election Committee members, the date and venue of the meeting etc. would be published in our May, 2022 issue. But before that all the centres would be advised by Whatsapp message also by us. Every member is welcome to attend the meeting as and when it is held. The members who wish to participate should have got both the doses/vaccination of Covid-19.

In the last but not the least, our heartiest thanks to the SBI Management at LHO Chandigarh especially AGM PPFG, AGM HRD and AGM OAD and Chief Managers of PPFG Deptt. and H.R. Deptt. at LHO for their utmost cooperation and help to continue our activities of the SBIPA. I am thankful to all the members of Chandigarh Circle in general and S/Sh. K.P. Joshi, Offg. President; K.K. Trikha, Dy. General Secretary; S.K. Sharma, Treasurer; S.C. Aggarwal, Organising secretary; H.K. Sharma, Asst. General Secretary and Tek Chand, Asstt. Treasurer, in particular for all the support extended to me to enable me to discharge our duties/work for the welfare of our members. I wish you and your families a very happy, healthy and peaceful life in the future.
