**MEDICAL INSURANCE SCHEME – POLICY 'A' & 'B'***

We report to this house that on repeated persuasion made by our Federation in various forums with the Corporate Center to provide medical assistance to staff removed from service was accepted and now the pensioners removed from service have become eligible to become the members of policy 'B'. We are proud to submit that for the first time sanction of subsidy to policy 'B' members was considered by the bank in the year 2017. Though it was discontinued later, we are happy to inform that the same was extended to all those who have completed 70 years of age and to all Family Pensioners irrespective of age. The worrying factor of hike in premium every year was being mitigated by the Bank by compensating cost of premia to Insurance Companies to some extent apart from providing subsidy in premia to pensioners as above. But, the present contract with SBI General Insurance Company is coming to an

end with the current year ending on 15th January 2023. There are indications from the Insurance Brokers M/s Anand Rathi Insurance Brokers Limited that there would be hike in the coming years given the fact of rise of claims. We are taking up this issue seriously with the Bank. However, the Mediclaim Policy is not without problems in the scheme. There are delays in getting reimbursement of medical expenses due to deficiencies in providing the required information by claimants and seeking of the same data again and again by TPAs. There are umpteen number of mistakes in the names of policy holders including the gender factor. Delivery of ID cards to policy holders. Release of buffer amount in respect of Policy 'A' holders. Irrationality in classification of Tier I, II, III centres.

We have taken up the above issues with the Insurance Brokers, TPAs and Management at AO/ Circle level.
