2022 addressed to The Chief General Manager, State Bank of India, Chandigarh LHO



MEDICAL FACILITIES

We wish to bring to your kind notice, a few of the following issues raised by the Pensioners which would be in the interest of working staff too on the captioned subject.

i) One of the tests from the list of 34 cashless tests at empanelled labs i.e (GGPD) is enzyme test which is very rare deficiency in Indians. As such it may be dropped from the list of cashless tests and the list be modified as per the current needs to include tests such as Vitamin D, Vitamin B-12, Echo-2D.

ii) Allocation of monthly medicines budget to the modules is not allocated as per the staff strength. Thus the staff is undergoing hardships. This needs to be looked into and the allocations may kindly be enhanced appropriately.

iii) At large centers, Physiotherapy center may be identified and cashless facility made at par with current empanelled labs (cashless) which will be of great relief to the staff, both in service and retired, and their dependents. Even the dispensaries can have the facility of Physiotherapist on contractual visit basis without involving much of additional expenses. It will not only be a relief to the pensioners but to the working staff as well who have to take a day off for the purpose.

iv) At big centres, there is a need of empanelling more diagnostic centers to save Senior and Super Senior citizen (pensioners) from traffic hazards.

Please arrange to get the issues examined on priority basis.

RESPONSE FROM MANAGEMENT

Text of reply received from the bank to our letter No SBIPA/22/2 dated 5th July ,2022MEDICAL FACILITIES

We refer to your letter No SBIPA/22/2 dated 95.07.2022 on the captioned matter. In this connection, we have examined the issues raised by you and our responses to these issues are as under:-

1. The 33 listed tests available to serving as well as retired staff members on cashless basis under staff welfare activities are prescribed by the corporate centre and no modification can be done at circle level
2. The expenses on the medicines are incurred as per the discretionary powers of the DGM(B&O) and no allocation of budget is done from LHO to the modules in this regard.
3. The issue of engaging Physiotherapist at zBank Dispensaries will be taken up with the corporate centre in due course for their consideration
4. We already have tie up arrangements with diagnostic laboratories at all big centres namely Chandigarh, Panchkula, Karnal, Rohtak, Mohali, Ludhiana, Amritsar, Jalandhar, Shimla and Jammu. We will ensure best medical facilities for our serving as well as retired employees in future also,

Text of our letter dated 25th July 2022 addressed to the Chief General Manager SBI LHO Chandigarh.

DENIAL OF RIGHT TO FAMILY PENSION TO A PHYSICALLY CRIPPLED /MENTALLY RETARDED CHILD IS VIOLATION OF ARTICLE 14 OF CONSTITUTION OF INDIA.

It has come to our notice that the bank is keeping pending/rejecting the requests received from the pensioners for inclusion of the names of their physically crippled/mentally retarded children as beneficiary to the family pension. The reasons cited for rejections are:-

1. The pensioner omitted to furnish such information before retirement;
2. the disability occurred after the date of retirement.

"The family pension under rule 54 of CCS (pension) rules is a welfare scheme framed to provide relief to the widowed members, children of deceased employee or pensioner" is a quote from the "Handbook on family pension under CCS(pension) rules 1972 published by Government of India, department of pension and pensioners welfare in January 2020.

The instructions contained in this booklet also clearly mention :-

" Non inclusion of physical mental handicap does not make a child in-eligible for family pension. A disability certificate issued after the death of employee/pensioner or his/her spouse for a disability which existed before their death may be accepted by the appointing authority."

Further, government rules provide for family pension to a spouse even though the marriage has taken place after the retirement of the employee.

Moreover, a recent historic judgement by Punjab & Haryana High Court in respect of CWP 15387 of 2017 pronounced on 11th May 2022 aimed at safeguarding the right of children adopted after retirement and ensuring the family pension to them has made the things very clear. The judgement says :-

"Mainly because the child adopted is post retirement which is mainly for the purpose of dependency and some light in the evening of life of the couple, the same would not as such be good enough to deny the said child the benefit of family pension merely on account of the fact that the decision as such to adopt was taken at a belated date."

In the above case the court quashed family pension rules denying the benefit of family pension to such child as violation of article 14 of constitution of India because these rules were discriminatory against children legally adopted after retirement and kept them out of the ambit of family pension.

In view of the above, we request you to kindly consider all such cases favorably. A little favorable consideration will provide much needed solace to the parents in distress who have already been suffering for years due to handicap of their children.

In terms of Regulation 37 of Bank Employees' Pension Regulations, 1995 Dearness Relief is payable to pensioners at rates specified in Appendix II to the Regulations.
